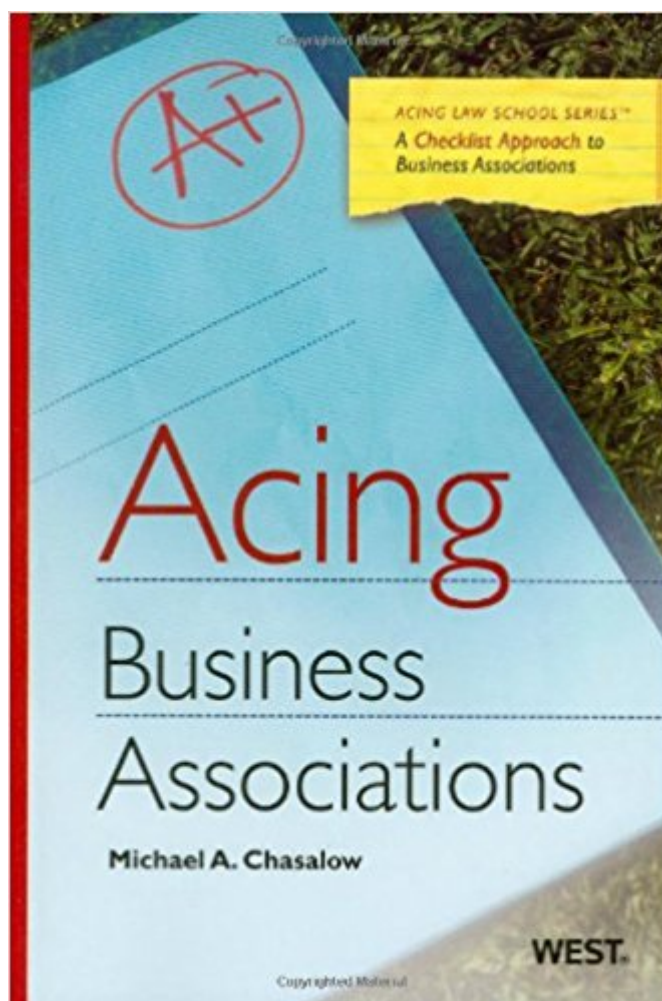

## Customer Reviews

If you prefer to read a short, succinct book rather than a dry outline with bullets, I believe this one may be for you. This book is filled with explanatory paragraphs that are punctuated by information bullets and tips. There is also a helpful summary at the end of each chapter. I understood nothing and this explained everything including all the nuances/differences I should remember. It also tells you when to refer to your specific state law so you don't waste your time on general statements. I was able to read this in 2 days, and I made an A- in my business associations class.

I found this book to be a great overview of business associations. This book is not as solid as Acing Civ Pro but I think the subject matter plays into that. I used the Klein casebook and most of this book followed it. I found the agency, partnership and the securities sections the most helpful. I found the corporations section the least helpful but nothing helped except my class notes since it is such a professor specific topic. I read each section before we reached that point in class so I had an

overview before we covered the topic. That is how this book should be used. I am the kind of person that needs context otherwise I sometimes get lost in the fine details. This guide provided that needed context. I read each section, skimmed the checklists and did the hypos. It is nice that each section has mini-hypos with explanations. Some problems were similar to my multiple choice questions on my final. It is hard to pick up an old outline and study it without context, but this book makes it possible. This book is great for what its intended purpose is: to give an overview of a detailed and complex subject. I would recommend it to anyone taking BA in law school. If you want to get a head start on BA it is feasible to read this book in a day or two then study an old outline of your professor's class. You should get no worse than a B+.

The usefulness of of this will depend on your particular class and professor. This is fine if you need broad brush strokes, but it doesn't get into the weeds nearly as much as I'd like in a supplement. I will also say I found what I think were some errors in the law, and as some have mentioned, many typos. If I did it again, I would probably buy a nutshell instead.

I bought this book because I am taking BA but do not have a background in business. This book is very helpful because it breaks down the concepts and key terms so that when I read the case or go to class I am not completely lost. I do wish the book had an index so it would be quicker to get to somethings but the table of contents is clear enough that you can find what your looking for in the ball park range and just read through that section to find the specific term or concept. I haven't taken the final for the class yet so not sure if I will be Acing BA but honestly it has been the best supplement I have used in law school. If you need help getting the concepts and overall gist of BA, definitely get this book. It is very helpful.

I bought this book because I was totally lost in my Bus Ass class. I just needed a general overview so that I could see how everything fit together, get some black letter law, and some real-life examples. After reading / outlining this book, I totally understand the course now. Is not a substitute for paying attention / reading in your class but helps so that you can follow class discussion and understand cases better.

Seriously helped me pass my BA class because I had no idea what was going on. Would definitely recommend this book if you're having difficulty understanding the concepts or just not interested in BA. It breaks it down for you really well. At my law school, this is the book everyone recommends

you to buy over any other supplement.

This book is wonderful! My case books are really thick and if you buy a hornbook, it is equally big. I needed something small that would give me the idea that I needed to grasp and move on. This book is right on point. Also, it gives you tips on what to do and NOT DO on the exam plus a great checklist to follow for exams. I love it. I only bought this one but saw that they have them for every subject. I will be getting the other ones as well. If you want a great book to help you learn how to identify issues and write your exams, this is it!

I always enjoy reading different sources or statements of the law to broaden my knowledge. The first half of this book provides a tremendous, concise review of LLCs and partnerships, however, there is less about corporations than I would prefer. The latter half of the book is inapplicable to my course curriculum.
