

For nearly twenty years, Tony Norfield worked in bank dealing rooms in the City of London. For ten

years he was an Executive Director and the Global Head of FX Strategy in a major European bank, travelling to some forty countries on business, negotiating with finance ministries, central banks and major corporations. He was frequently quoted in the Financial Times, Wall Street Journal, Guardian and Telegraph, and on news services such as Reuters, Bloomberg, CNN and CNBC. In 2014, he was awarded a PhD in Economics from the School of Oriental and African Studies, University of London.

Very scholarly, an informed global view, less of the inner workings of the City than I expected but very ably explains how the English have badly hurt themselves by the Brexit vote, which is certain to damage the City's position in the world and thus the living standards of the British. This book is not written from any particular point of view, i.e., not capitalist or socialist or any other -ist or -ism, but is a solid piece of scholarship by someone who has many years of intimate knowledge of how finances in general, and the City in particular, actually work and how they impact the lives of the rest of us.
