

I could not believe how bad it was, compared to my old book. I had a similar course several years back, and my wife borrowed my old book to complement this poorly written tome. She put somewhere around 75 flags in my old book, while this one merited just three. There are much stronger books out there from Rothstein, Murdick, and Yell. You may also want a reference book like Wrightslaw. Avoid this horrible text at all costs.
