Jennifer Griffith is a go-to author because she has a way of combining a great plot with a swoony romance that gives me butterflies, yet it all stays clean. The books in this series can stand alone and they're all worth reading. Jillian, or Jilly, is a lawyer and that's one profession that I don't think I could ever do, yet she's good at it. Her teenage client, Ryker, is a Hollywood star and I must say, at first I

was expecting Justin Bieber, but what I got was one hilarious and quirky character that kept me on my toes, rolling my eyes, and laughing at loud. Is it possible for a teenager to be a matchmaker? Ryker is definitely trying hard to get two of his favorite people together and his reason for it melted my heart. Aero is a great character and the yang to Jilly's ying. They're each so strong and there's no hesitation at all in their actions, yet they complement each other so well. I love characters who know who they are and aren't afraid to be true to themselves. I love the way the author incorporates art and legalese into a story about following dreams, discovering deep down hopes, and finding passion, all while set in California. When Jillian Price finds a rare painting at a garage sale, she can't believe her luck. But it's her newfound acquaintance, Aero Jantzen, who gives her the push to follow her dreams. Jilly is a high-priced attorney, but she really wants to run an art gallery. Aero is a banker who also works as the agent for their mutual high-maintenance client, teenage actor Ryker.But the painting hides secrets that may derail the budding romance of Jillian and Aero despite the efforts of Ryker to get them together. This is a really cute novella and an easy read. All the characters, main and secondary, are interesting and fun. The information about the art world was pertinent as well as the legal/banking information, but not overwhelming the romance. Another great addition in a good series. I received this book as an ARC and opted to give an honest review.

I used to be put off by the romance genre because everything was focused on the physical, in the moment, and without thoughts for consequences or the future...too unrealistic and shallow. Then I heard about a tribe of authors dedicated to writing clean romance and decided to check them out. I am so glad I did. Jennifer Griffith is a pioneer in her field. I have enjoyed every book she has written, including Mergers & Acquisitions. I appreciate knowing that I can read clean romance that also has substance to it. The characters in her books are well developed and not 100% focused on the physical aspect of a romance. Instead, there is the perfect blend of those emotions expressed in her work that complement the story and her characters. Her novels also include tidbits of information that I find refreshing.

I have to say I love this series as well as anything I've read by Jennifer Griffith. I know she'll have

clean romance with humor and a bit of surprise in each of her books. This book is no exception. I enjoyed the Hollywood aspect of the book with the history, the art, actors, theme parks, kids, and more. I went to Huntington gardens as a teenager and this brought back a few good memories. No matter what the setting is, though, the best part was the people. Who doesn't love a grandma? Or a man who takes care of his grandma?
