

Much of the information for this book comes from trainings, workshops and articles we have prepared together and presented professionally. We have organized the information into three sections: Anatomy, "Bunk" and the Courtroom. We have included a glossary at the end for quick reference as well as a list of recommended resources. Part 1: Anatomy is divided into sections on the examination and treatment of all patients, female anatomy, and male anatomy. Part 2: "Bunk" addresses common myths and misconceptions that often undermine the investigation and adjudication of sexual assault cases. We also look at the evolving definition of rape and the difference between criminal statutes that require force as an element and those that require only a lack of consent. Part 3: The Courtroom offers a very brief overview of criminal procedure for context and then considers the collection of forensic evidence and general guidance to assist attorneys and witnesses as they prepare for trial. About the cover: The broken letters used in the title reflect the physical and emotional condition of many patients when they first come to the Fort Wayne Sexual Assault Treatment Center and present for treatment. The broken letters can also represent members of a Sexual Assault Response Team who are overworked, underpaid, and conscientious
